## YEAR 10 AND 12 WORK EXPERIENCE

I am writing to inform you of the schools' decision **not** to offer work experience for your child this year. The school and the education authority recognise the value of the work experience scheme, and the decision has not been made without serious consideration.

The Welsh Governments' decision was to terminate the contract that Careers Wales had to check the suitability of work experience locations. Gwynedd and Anglesey education authorities have worked together to set a system that would ensure that each location has been checked to a standard that would ensure the safety of your child but the national guidance on the need to check locations to a specific standard is unclear.

**Therefore, the authority's decision in conjunction with Gwynedd and Anglesey Secondary School Head teachers is to not offer work experience for your child this year in order to ensure safety before everything else. This decision has already been made across the rest of North Wales' regions and the majority of regions across Wales.**

If your child wishes to continue to go on work experience placement, we encourage you to make your own arrangements during school holidays.

The authority understands that this is disappointing news but the decision has been inevitable due to the circumstances.
